Signature (Owner)

1. Owner certifies the accuracy of all information Owner has conveyed about Owner's pet to ÜBERDOG.
2. Owner represents to ÜBERDOG that all credit card information Owner has provided to ÜBERDOG is accurate. Owner further represents that all information that Owner has given to ÜBERDOG about Owner is accurate.
3. Owner agrees that if Owner's pet becomes ill or seems to be in need of medical consideration, ÜBERDOG, at its sole discretion, reserves the right to administer aid and/or to engage the services of a veterinarian and the expenses thereof shall be paid by the Owner. Owner gives consent to ÜBERDOG to act on the Owner's behalf in obtaining emergency veterinary care at the Owner's expense if deemed necessary by ÜBERDOG. Owner agrees to indemnify and holds ÜBERDOG and its employees harmless from said expenses.
4. Owner understand that any problem, including but not limited to injury, illness or death that occurs while on our premises, all dog(s) will be treated as deemed best by the staff of ÜBERDOG, in their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
5. Owner agrees that their dog is in good general health, and valid proof that he/she is current on Rabies, DHLPP, Bordetella and Parvovirus vaccinations will be provided before she/he can stay at ÜBERDOG. In addition, Owner agrees that their dog is on a scheduled flea/tick prevention program. Dogs arriving with fleas will be refused service.
6. Owner hereby grants ÜBERDOG the right to videotape, photograph, and/or record their dog during their time at ÜBERDOG and to post and/or reproduce any and all photographs taken (as well as Owner's dog's name) on or in, without limitation, ÜBERDOG's website, promotional materials and merchandise, without becoming liable to the Owner or Owner's dog for any royalty payment of any kind. ÜBERDOG shall be the exclusive owner of the results and all such tapings, photography, and recordings will be used only by ÜBERDOG in its own promotion, advertising, sale or publicizing.
7. Owner agrees that should their dog exhibit inappropriate aggressive behavior toward other dogs or employees, for the safety of all concerned he or she will be placed in a secure dog run or be temporarily relocated to a traditional boarding facility of our choosing.
8. In the event a dog is abandoned at ÜBERDOG, due diligence will be undertaken to locate the owner. If the owner cannot be located, the dog will be delivered to the nearest animal shelter.
9. ÜBERDOG reserves the right to refuse any dog.
10. ÜBERDOG shall exercise reasonable care for Owner's dog while Owner's dog is in ÜBERDOG's custody. Owner recognizes the potential risks involved group play/dog daycare, boarding and grooming due to the unpredictable nature of dogs.
11. Owner further agrees that the pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangement are agreed upon by both parties.

12. Any claim or controversy arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall, as part of his/her award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney fees of the prevailing party.

13. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and ÜBERDOG.
